Vacation:

3.08.01 Paid Annual leave is granted to full-time associates

3.08.02 Part-Time and temporary associates are not eligible to accrue annual leave.

3.08.03 Full-time associate is eligible to use accrued annual leave after he or she has completed ninety (90) calendar days of employment with the City of Hartshorne.

3.08.03.1 Annual leave will accrue during a full-time associates first ninety (90) days of employment in a full-time position; however, it may not be used until the pay period following the completion of the ninety (90) days.

3.08.04 Requests for annual leave must be made to the associate's supervisor/manager for consideration.

3.08.05 Available annual leave balance is paid out upon separation of employment.

3.08.05.1 Annual leave shall be forfeited due to theft and/or embezzlement. 3.08.05.2 Annual leave shall be forfeited due to lack of proper two week notice.

3.08.06 0-3 service years as full-time associate 40 hours annual leave 3 service years and up as full-time associate 80 hours annual leave. No accrual.

3.08.07 Use it of lose it by December 31st annually

Sick Leave: 3.09.01 Paid sick leave is granted to full-time associates

3.09.02 Part-Time and temporary associates are not eligible to accrue sick leave.

3.09.03 Sick leave shall be used by the associate to care for themselves or the associate's immediate family member due to an illness, accident, or medical appointment for a limited period of time.

3.09.04 Full-time associate is eligible to use accrued sick leave after he or she has completed ninety (90) calendar days of employment with the City of Hartshorne.

3.09.04.1 Sick leave will accrue during a full-time associates first ninety (90) days of employment in a full-time position; however, it may not be used until the pay period following the completion of the ninety (90) days.

3.09.04 Requests for sick leave must be made to the associate's supervisor/manager for consideration.

3.09.05 Associates shall provide verifiable documentation from a medical provider to their immediate supervisor upon request. If an associate is off work for longer than three (3) days, such documentation shall include instructions on when the associate is permitted to return to work.

3.09.05.1 Any medical documentation received by the supervisor/manager must be submitted to timekeeper upon request.

3.09.06 Available sick leave balance is not paid out upon separation of employment or change in status from full-time to part-time or temporary.

3.09.07 Accrual for full-time associates is 80 sick leave hours annually for fulltime associates or 3.08 hours each pay period. Not to exceed 120 hours.
