D. Charlie Rogers and Wade Mathis to address Council concerning the roads in Hartshorne.

Rogers addressed Council explaining the County's Budget and how other towns had applied for outside monies for the County to come in and repair/restore roads. Discussion of drainage issues were addressed including concerns with WPA ditches. Rogers advised that the cost of Chip and Seal per mile is \$32,000.00 and the cost of asphalt per mile is \$50,000.00. He continued saying the County would most likely spend a lot of the summer working on roads within Hartshorne.
